



## Nepal Health Sector Support Program (NHSSP) Request for Proposal

Nepal Health Sector Programme 3 (NHSP-3) is funded by UK Government through Department for International Development (DFID) to provide technical assistance to Ministry of Health and Population (MOHP) through Nepal Health Sector Support Programme (NHSSP). NHSP-3 is designed to support the goals of Nepal Health Sector Strategy (NHSS) 2015/16-2020/21 and assist MOHP in building resilient health systems to provide good quality health services for all.

From April 2017 to December 2020, NHSSP is being implemented by a consortium led by Options Consultancy Limited, with Health Research and Social Development Forum International, Oxford Policy Management, and Miyamoto International. The programme has two components.

- A. General Health Technical Assistance to increase the capacity of the MOHP to improve health policy-making and planning, procurement and financial management, health services and the use of evidence for planning and management and
- B. Retrofitting Health Infrastructure Technical Assistant to enhance the MOHP capacity to retrofit health infrastructure to withstand future earthquakes.

The NHSSP comprises of streams of work delivered through an overarching, integrated, capacity enhancement approach. These five streams of work are:

- Health Policy and Planning
- 2. Procurement and Public Financial Management
- 3. Service Delivery
- 4. Evidence and Accountability, and
- 5. Health Infrastructure

NHSSP is now seeking to contract an organization that specializes in training and delivery of physiotherapy services to design, implement and monitor this activity. It is anticipated that the task will have the design phase, training phase, monitoring phase, and dissemination phase for this assignment.

Your offer comprising of technical proposal and financial proposal, in separate sealed envelopes, should reach the following address **no later than 17.00 hours on the 15th November 2018**. Technically qualified bidders are only eligible for financial evaluation. The proposal should respond to the terms of reference as specified in detail in NHSSP Website **www.nhssp.org.np** not exceeding 25 pages. In addition to the proposal, annexes of no more than 2 pages each should be included on: (i) a fully itemized budget; (ii) implementation plan and timeline and (iii) summary CVs indicating relevant experience of key personnel. Also as a pre-qualification requirement, the organization should also submit the (a) Registration documents, (b) PAN/VAT certificate and (c) Tax clearance certificate for FY 2074/75.
