PREFACE

CHAPTER 1- INTRODUCTION

1.1 Background

The constitution of Nepal has established the basic right of people to receive quality health services. The GoN is committed to provide such services by means of making available free quality drugs and medical equipment including service facilities and technical human resources. The NHSS, 2015-20 addressing the health challenges of Nepal ensures access to free basic health care services with quality, more transparent and accountable to the people. In the direction of implementing this strategy, MoHP has to mandate its departments, centres, councils, zonal and tertiary hospitals and several PEs to be involved in procurement proceedings. MoHP has endorsed the FMIP, 2016-2021 and PIP, 2017-2021 under this strategy. Both the documents outline the importance of improving procurement practices in the health sector by implementing reform initiatives that will contribute in resolving the current issues related to the procurement cycle. As a part of this realisation, CMC has been established at the DoHS for monitoring of procurement cycle. And the DDA and DoA are also committed to starting the functionality of APP through CAPP and make the monitoring of CAPP through the CMC more effective.

1.2 Rationale

Procurement Planning is not only a powerful tool by which future actions on procurement can be better forecasted and managed but also is a kind of monitoring tool. It is needed to acquire the required medical goods, services and works in time, with quality and within the estimated cost. A Procurement Plan will describe about what to buy? How? Where? How much? At what price? and When to buy?. Only a good Procurement Plan can assure procurement with Economy, Efficiency, Transparency and Fairness.

Initiatives on preparation of APP of all procurement centres in health sector have been practiced since the inception of the PPA and PPR in 2007. As an impetus of NHSP-1 and NHSP-2 the evolution of CAPP of various divisions functioning under DoHS has been monitored from FY 2014-15 by LMD of DoHS and NHSSP. Significant effort has been made to consolidate the APP prepared by the various divisions of DoHS and monitor its implementation by the CMC established in FY 2017-18. However, the CMPP has not been started both at MoHP and DoHS.

LMD/DoHS while preparing CAPP 2017/18 committed in its report that CAPP must be prepared for the Federal Ministry level under which several procurement entities exist. The CAPP should include all

goods, works, consultancy services and other services to be procured under MoHP in FY 2018/19. Efforts have been done to sum up as most APPs of procurement centers of MoHP and consolidate them in a single document. In the due process of CAPP preparation in 2017/18, it has been also reported that CAPP of Health Sector is still not sufficiently comprehensive that all the procurement disbursements from MoHP to its PEs are not tracked in order to ensure value for money (VfM). Therefore the PIP, 2017-2021 planned to step towards consolidation of all APPs of MoHP's procurement centers. And at this momentum effort, this CAPP, 2018/19 has been prepared comprehensively incorporating all PEs under MoHP so that all the procurement disbursements from MoHP to all its federal health institutions are tracked in order to ensure effective monitoring for VfM of health sector.

1.3 Legal Framework

The provision of preparing APP has been included in Article 6 of the PPA and Rule 8 of the PPR. The CAPP shall be prepared as part of AWPB of MoHP as per Rule 20.1 of FPR. In the case of multi-year procurement, it requires to incorporate the budget as per the MPP. The rationales for preparation of CAPP is more pronounced by the legal mandate that:

- A Public Entity must prepare a MPP for procuring for a project to be more than one year or planning the value of procurement exceeding one hundred million Rupees annually.
- A public entity planning to procure more than one million Rupees in a year needs to prepare an APP.
- The APP shall be prepared as part of the estimated AWPB of the forthcoming fiscal year.
- The chief of the entity shall send a copy of the APP, accompanied by the estimated AWPB for the forthcoming financial year to MoHP and MoF.
- The chief of entity shall, upon receipt of the approved AWPB for the current financial year, accordingly revise the APP prepared, approve it and send a copy of such plan to MoHP.

1.4 Objectives

The overall objective of this task is to prepare and finalize the comprehensive CAPP for the procurement of goods, works and services under MoHP. It will enable MoHP to organize and schedule its procurement activities within the following specific objectives:

- Medical goods, works and services are delivered in a timely manner and adequate stocks of essential drugs are maintained for the effective supply chain management;

- Manage the work load of the procurement officers out over the year making them responsible to accomplish milestone activities as per schedules of the plan;
- The evaluation committees are appointed in a timely manner and the members are made responsible to accomplish milestone activities of the plan; and
- The finance section has prepared the cash flow plan of the organization and adequately managed payment schedules.

It is important to understand that the purpose of this report covers only the process followed for preparation of the federal level's APPs and their aggregation into a comprehensive CAPP under MoHP. This report does not cover Local and Province level AWPB and procurement activities, general procurement process, MPPs or the process to aggregate them into a CMPP, which shall be the subject of a separate report.

1.5 Methodology

MoHP requires strengthening the APP and CAPP preparation process. This report highlights the methodologies that considered while developing and finalising both APP and CAPP in the federal level. The respective federal procurement entities now we can be seen in **Annex-1** of this document as an integral part of the CAPP. The Bottom-up approach and Participatory methodology was adapted to consolidate all the APPs of all procurement entities under MoHP into single and comprehensive document of CAPP in federal level. Federal AWPB of MoHP entered in LMBIS of MoF is used as a prima-facie plan document (NPC Form No.1) for the preparation of CAPP for 2018/19.

Individual APP of PEs shall be prepared as part of the estimated annual development plans (ADPs) of the forthcoming fiscal year in the format prescribed by the NPC form no.1 in Rule 20 of FPR. On the compilation process these ADPs of all Departments and PEs under MoHP are collected and compiled by PPICD of the MoHP in the due process of budget estimation procedures. AWPB is prepared on the base of ADPs proposed by individual procuring entities along with the supporting document as APP for next year.

A two day workshop was organised to streamline this process, shared the individual approved AWPB and APP and built consensus for the final CAPP. All procurement entities under MoHP participated in the workshop and a final CAAP report was prepared as a result of this exercise.

NHSSP-PPFM team has supported to shape the CAPP and other relevant documents required to organise the workshop. Details of the participants are included in **Annex-3**.

The local and provincial government can also use this process, methods, formats and guidelines, included in this report as the reference for their APP/CAPP. As a live document MoHP will update this report periodically, based upon the feedback and progress received.

CHAPTER 2- CAPP PREPARATION PROCESS

2.1 Current Status

In FY 2017/18, the Department of Health Services prepared the CAPP. The progress made in the execution of CAPP has been reviewed in the meeting of CAPP monitoring committee (CMC). The PIP has been endorsed in late 2017/18. In this context, 2017/18 is the first year of its execution. The CMC also been active from current fiscal year. The update and digitalisation of TSB has also been started in this fiscal year. A total of 300 users have been logged into the TSB system. It is important to note that the officials from local level have been logged into the system. Apart from that, LMD has taken lead role in preparing, endorsing and despatching the SOP and TSB manuals for local governments. The Electronic Government Procurement (eGP) system manual has been finalised which is now ready to be dispatched to the local level. These initiatives not only improve the capacity of LMD but also facilitates the process of strengthening procurement functions at local level. In current FY 2017/18, around 90% of CAPP's estimated amount has been moved into the procurement cycle. This has been improved from around 80% in FY 2016/17. In this fiscal year LMD has initiated the use of eGP-II. All procurements have been made through the eGP-II since November 2017. LMD website is now fully updated where the CAPP since 2012/13 are uploaded, TSB included, feedback mechanism included, regular update of procurement notices and publications are uploaded. MoHP has initiated Grievance redressal system at MoHP. Within that grievance icon is now included in MoHP's website. The concerned people can send their feedback at gunaso@mohp.gov.np. The progress made in the implementation of PIP also discussed at meeting of PFM committee.

2.2 Preparation of APP

The first important step before initiating the APP from all the HIs under MoHP is to make a decision on the items to be procured for coming year. For this, a list of drugs, vaccines, contraceptives and medical equipment to be procured and distributed to the health facilities needs to be prepared and finalized. After finalisation of procurement need, all procurement entities shall prepare their AWPB for budget process along with their APP as a support document. For instance in the DoHS level, LMD should take the lead role in ensuring the procurement of drugs using the approved essential drugs from TSB. Likewise DDA, DoA and all federal level procurement entities shall follow this procedure. The list of equipment will, however, be based on actual indents from the health facilities, which should be consolidated every year before bids are invited.

2.3 Consolidation of APP

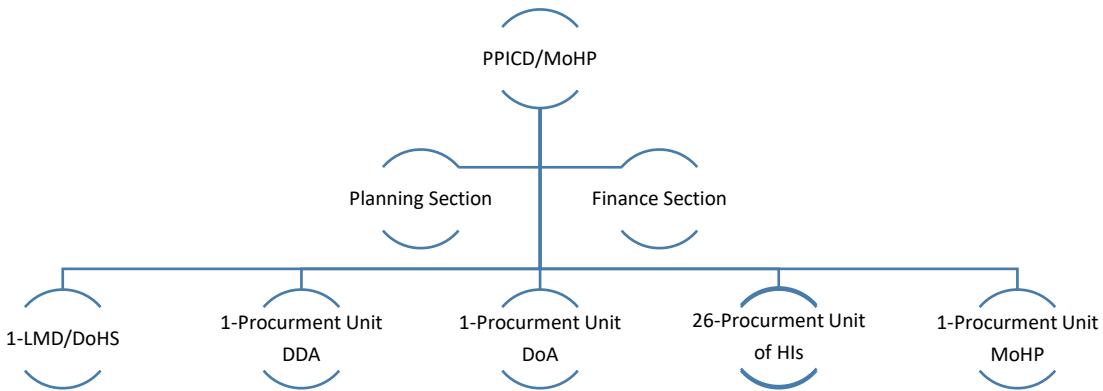
Upon receipt of the approved AWPB for the forthcoming financial year, the concerned federal PEs shall revise their individual APP and send the same to the respective Departments and MoHP for consolidation. MoHP prepare and finalise CAPP where it includes all the procurement work of forthcoming fiscal year of all the federal procurement entities including all the processes with given timetable. As a federal ministry, MoHP has 1 Ministerial procuring entity itself, 3 federal departments and 26 PEs like centres, councils and hospitals which are individual procurement entities included in this document. Upon receipt of the approved AWPB for the forthcoming financial year, the concerned federal procurement entities shall revise their individual APP and send the same to the respective Departments and MoHP for final consolidation as a comprehensive CAPP document.

2.4 Comprehensive CAPP Consolidation Process

The Bottom-up approach is adapted to consolidate all the APPs of all federal procurement entities under MoHP in order to make a single and comprehensive document of CAPP for 2018/19. This is a first attempt of MoHP in preparing a comprehensive CAPP. All the procurement entities prepared their individual MPP and APP as a part of the AWPB of the forthcoming fiscal year 2018/19, which is prepared in procurement entity level, collected and consolidated in departmental level and sent to MoHP for consolidation. Within given ceiling of budget, MoHP collect all departmental and MoHP's AWPB and APP.

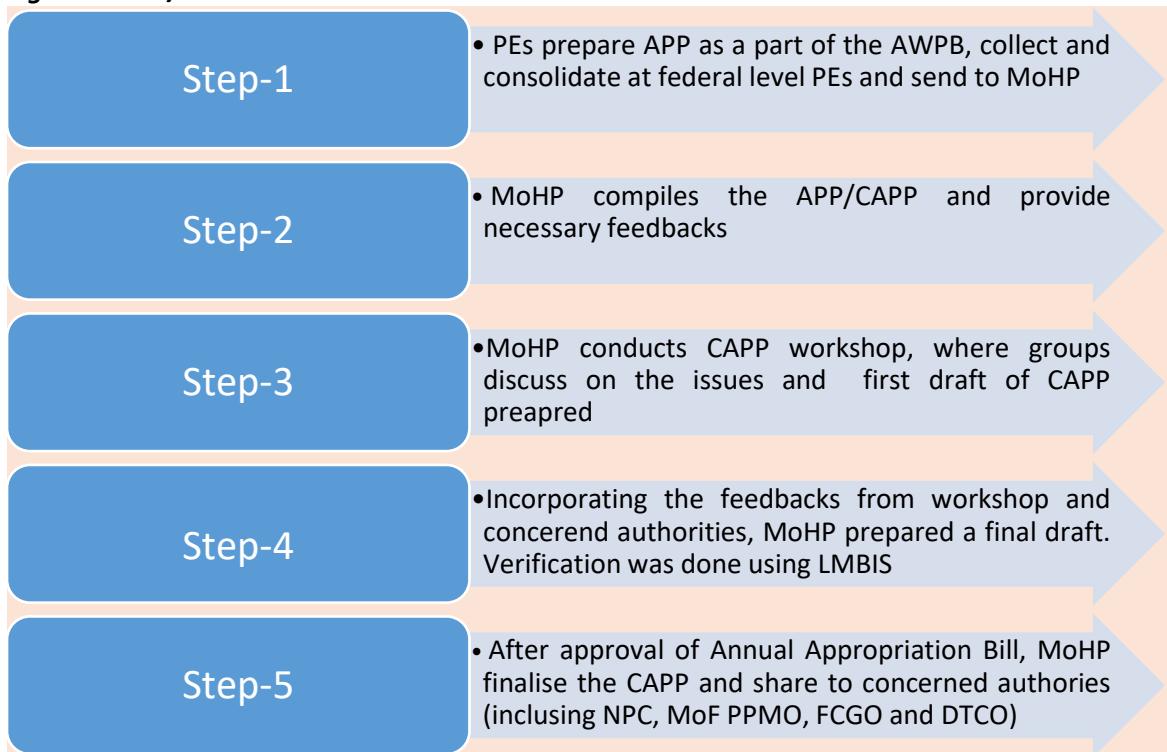
Estimated AWPB along with APP of MoHP and its PEs being prepared, collected and entered in LMBIS of MoF and is used as a prima-facie plan document (NPC Form No.1) for the initial draft preparation of CAPP for 2018/19. The following diagrammatic approach is adapted to collect and consolidate all the APPs from the concerned departments and PEs.

Figure 1: Comprehensive CAPP Consolidation of PEs



As figure:1 depict there are 30 federal level procuring entities that are incorporated in this CAPP report. The following procedural approach and methodology is adapted to consolidate all the APPs from these PEs.

Figure 2: APP/CAPP Consolidation Process



APP is prepared as part of the estimated ADPs of the forthcoming fiscal year in the format prescribed by the NPC form no.1 as per FPR. On the compilation process these ADPs of all Departments and PEs under MoHP are collected and compiled by Planning Section of the PPICD/MoHP in the due process of budget estimation and formulation procedures. AWPB is

prepared on the base of ADPs proposed by individual procuring entities along with the supporting document as APP. CAPP for the fiscal year 2018/19 is included in **Annex-2**.

2.4 Comprehensive CAPP Budget Analysis

There are 30 PEs and 58 Budget Codes associated with procurement function in health sector.

This report covers 30 PEs and their 32 Budget Codes. The list of PE are included in **Annex-1**.

NPR 34.08 billion is appropriated for health sector and out of this total health sector budget NPR 5.94 billion (17.4%) is for procurement budget. This Procurement budget is divided into 4 modalities of procurement, i.e. Construction of PEs, procurement of Goods, Consulting Services and Other services. Comparing with the total budget of health sector, Construction of health institutions represents 4.2%, procurement of goods represent 11.9%; Consulting Services 0.5%

and 0.8% is for Other Services procurement. Among NPR 5.94 billion of procurement budget, Construction of health institutions represents 24%, procurement of goods represent 68%; Consulting Services 3% and 5% budget is for Other Services. Out of NPR 5.94 billion of procurement budget NPR 4 billion (68%) is for procurement of goods and almost 34% budget is for procurement of drugs and 26% of budget is allocated for procurement of medical equipment. Out of 4 billion of procurement of goods budget almost 50% budget is allocated for procurement of drugs, 37% for procurement of equipment and rest of 13% budget is for other goods.

CHAPTER 3 - CONCLUSION AND WAY FORWARD

3.1 Conclusion

MoHP prepares the CAPP that is in compliant with the existing procurement acts, regulations and PPMO's procedures. The APP and CAPP templates are designed to fulfil the requirements to be followed by PEs. A well-prepared CAPP and its timely endorsement ensures the effective procurement functions, ensure the efficiency, assure the quality and maintain the transparency. The other components of procurement cycle are crucial to prepare, update and revise the APP and CAPP. Since this is a first CAPP of MoHP it requires institutional home with a clear ToR. For now, PFM committee can monitor the progress made in the implementation of CAPP. MoHP needs required resources to establish an entity, monitor CAPP implementation and quality assurance through cross verification. The absence of standard timelines for the preparation and finalisation of APP/CAPP can cause delays in the endorsement of CAPP, which in turn would lead to procurement delays, and stock out situation for the essential drugs. This CAPP provides a comprehensive information on the annual procurement activities of the entities functioning under MoHP. It does not include the APP of the grants provided to Provincial and Local government. Additionally, it also does not include the procurement from local revenue.

3.2 Challenges

3.2.1 Role of LMD/DoHS

LMD has been established to procure and manage supply chain of essential medicines and medical equipment required by various divisions under the DoHS. Previously DoHS's divisions prepare their individual MPP and APP; LMD providing technical support to the divisions in preparing CAPP based on individual APP. Now, there are three levels of Government: Federal, Provincial and Local Government. The proposed organogram has merged current LMD under MD as a section. This brings an important question of the coordination within DoHS and outside DoHS.

3.2.2 Functional Institutional Home

There was no structured practice of preparing CAPP at MoHP level. The procurement entities under MoHP have been executing their APP individually. So it is realised that CAPP must be prepared for the Federal Ministry level under which several procurement entities are exist. The CAPP should include all modality of procurement like goods, works, consulting services and other

services to be procured. In the absence of proper institutional home, it will be difficult to monitor the progress made in the implementation of CAPP for FY 2018/19.

3.2.3 Uniformity in CAPP execution

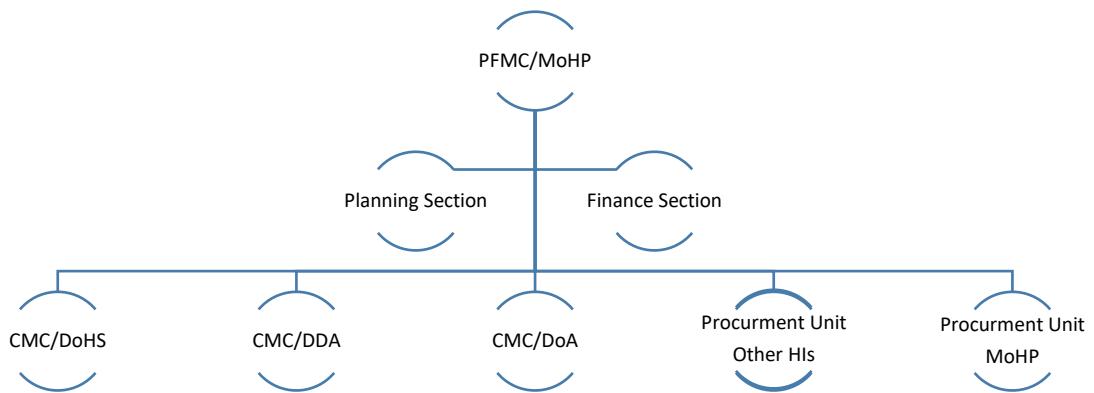
There are several type of PEs under MoHP, some of them enjoy independency in decision making through their Development Committees. These types of PEs earn their own income and expends on procurement of drugs and equipment which could not incorporated in present CAPP. Likewise, some PEs expends on procurement through their program budget which is appropriated in separate activity budget code other than procurement budget code and due to the reason CAPP doesn't incorporate these figures at present. This type of procurement through their own resources and program budget are not incorporated in this CAPP for FY 2018/19. Most of the hospitals earn their own source of income and at this moment they are not incorporating the procurement program in their APP which is incorporating in CAPP.

3.3 Way Forward

3.3.1 Update of CAPP monitoring committee (CMC)

MoHP needs to formulate CAPP monitoring committee in DDA, DoA and other relevant PEs to review and monitor the progress made in the implementation of APP/CAPP. DoHS has already formulated CMC, which is active in monitoring the progress. The overall objective of CAPP monitoring committee is to monitor the progress and resolve any issues in the procurement processes. The Committee shall focus on CAPP's time plan and its implementation, review the progress of PIP, review the report of oversight agency, review the usage of TSB and make recommendations for the reform of procurement process. PFMC of MoHP is committed to monitor the meeting of CMC in every three months in each departments. MoHP needs to update the current ToR of PFMC to monitor the progress made in the implementation of CAPP FY 2018/19.

Departmental CAPP and its monitoring shall be monitored by PFMC at MoHP level whereas Departmental CMC shall monitor all APPs of its PEs as per CAPP from FY 2018/19. Above diagram shows a proposed procurement institutionalisation process under MoHP.

3.3.2 APP linked with AWPB

Development of the CAPP needs to be fully coordinated with the budgeting process. A first draft of the APP should follow shortly after the first draft of the AWPB. The finalisation of the APP happens after the approval of the AWPB. This will contribute in timely completion of APP/CAPP. The e-CAPP will support in linking APP/CAPP with LMBIS/AWPB/TABUCS.

3.3.3 Use of Technical Specification Bank (TSB)

Almost all-technical specification of medicines are used from TSB, however, the procuring entities themselves estimate the technical specifications of medical equipment. These procuring entities are using TSB only for the reference for their own specifications. LMD/DoHS have developed an on-line specification bank system where approved specifications can be uploaded and all procuring entities could easily access them. This has greatly improved the quality control and transparency in the procurement system of MoHP. MoHP needs to further improve the TSB of medicines and equipment. An agreed time frame and procedures needs to be endorsed by the MoHP.

3.3.4 Use of e-GP-II

Procuring entities within MoHP should use the e-Government Procurement (e-GP-II) Portal for procurement within this fiscal year. Procurement process should be carried out through online e-GP-II system, which will improve the overall procurement functions of MoHP. MoHP need support to and from PPMO to make health sector friendly e-GP-II.

3.3.5 Strong Contract Management unit within the MoHP/DoHS

MoHP/DoHS need to improve contract management processes. The present dilemma of tracking the contracted goods, delay by the suppliers and delay in payment must be improved by use of integrated Contract Management System with e-CAPP, which will be linked with the e-AWPB and TABUCS. Contractor's Ledger of each contract will be established within the electronic system. The CMC and PFM committee at MoHP shall regularly monitor the contractors' ledger.

3.3.6 Market Analysis for effective Cost Estimate

To bring more accuracy in budget and expenditure as well as to improve VfM by maximum execution of budget, accuracy in cost estimates are necessary. Therefore the PEs need market information on pricing trend and components of pricing. MoHP will conduct market analysis of drugs and equipment to determine the factors of unit costs with respect to the bidding conditions, quantities and places. The information shall be made available to all the PEs under the federal ministry as well as to the provincial and local governments.
